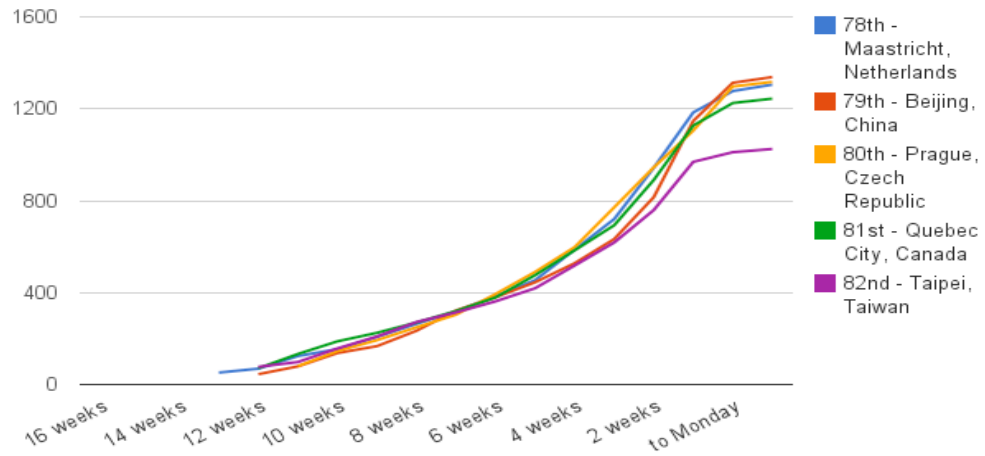

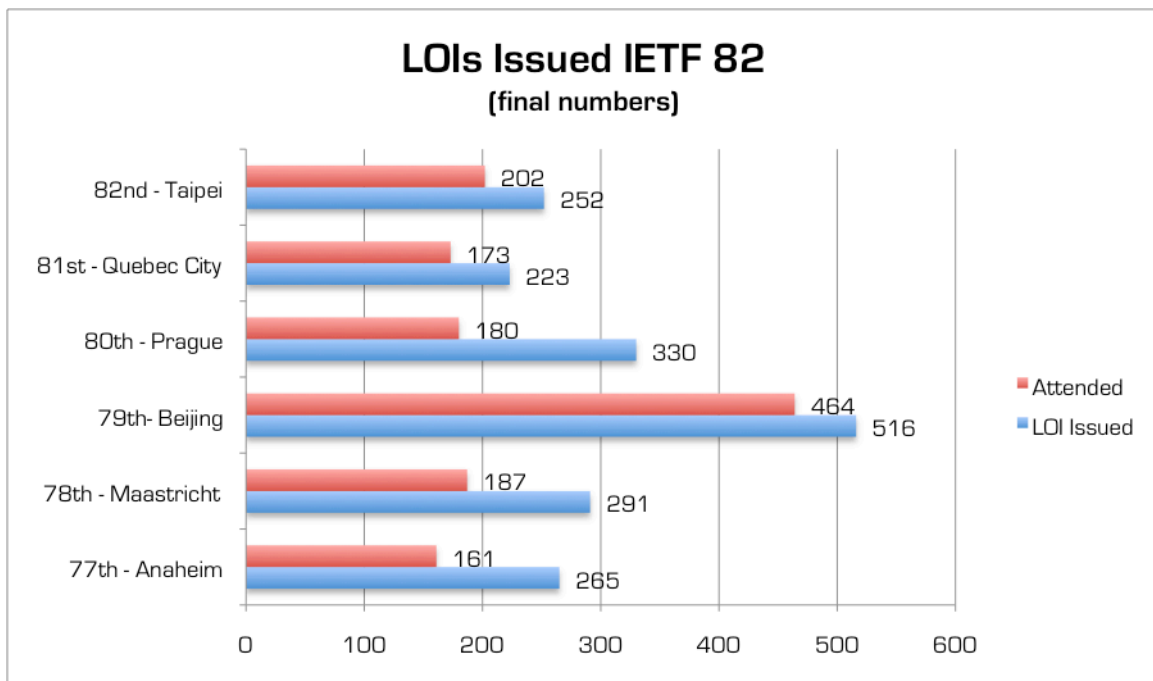

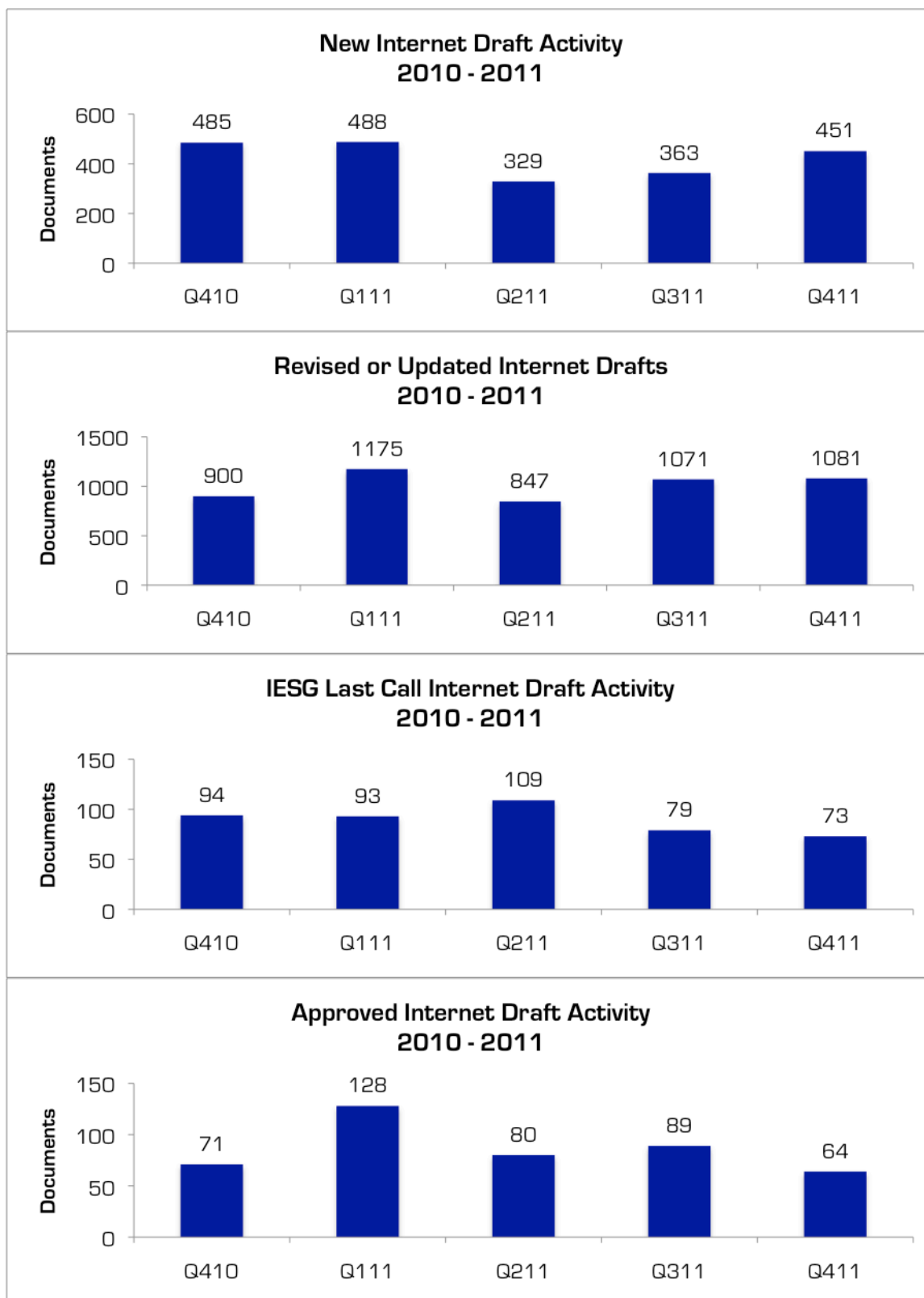
Registration Numbers

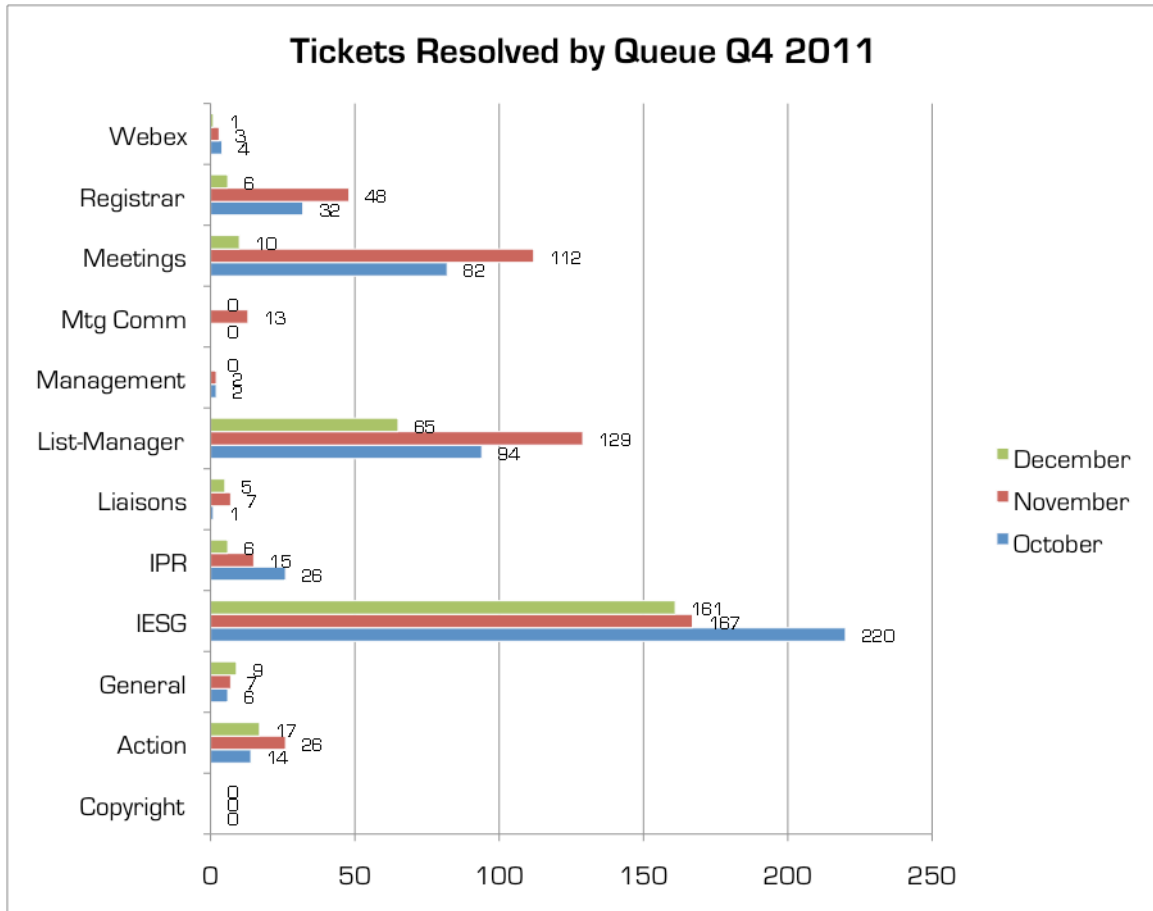
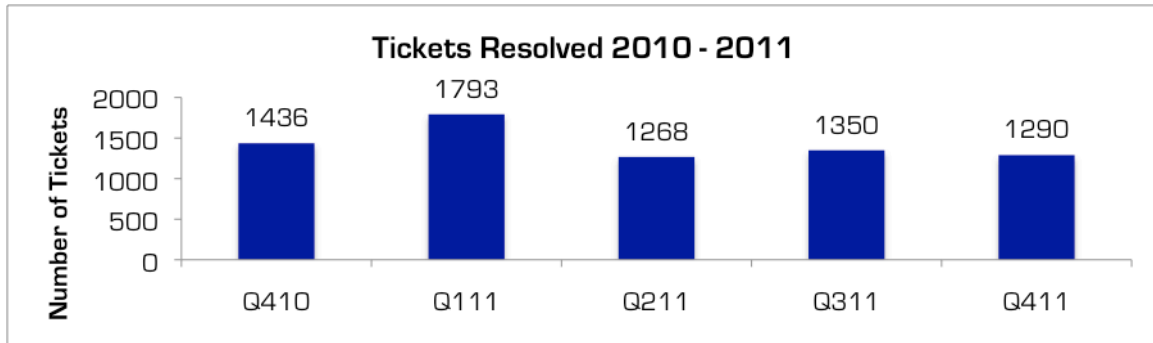

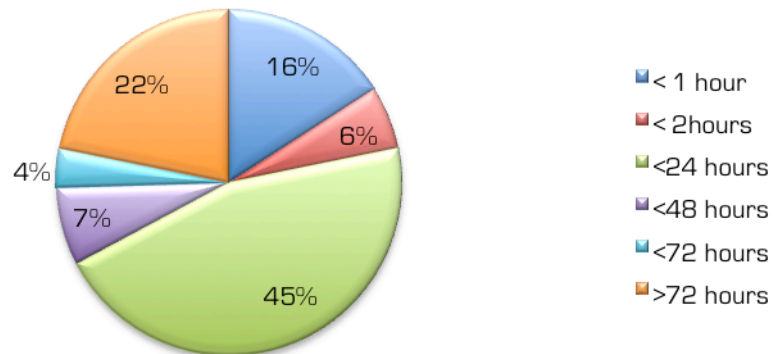
IETF Ticket Management (ALL TICKETS) **Q4 2011**



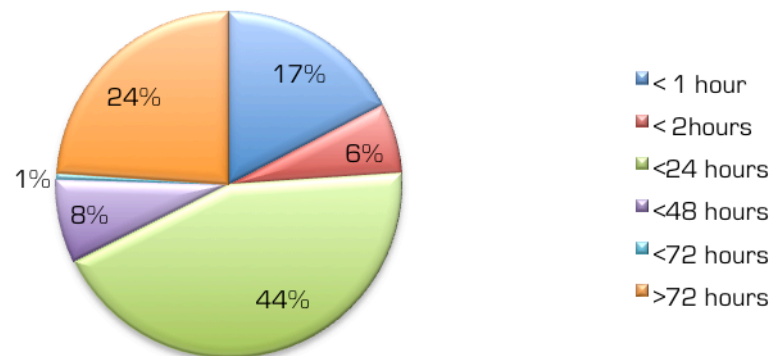

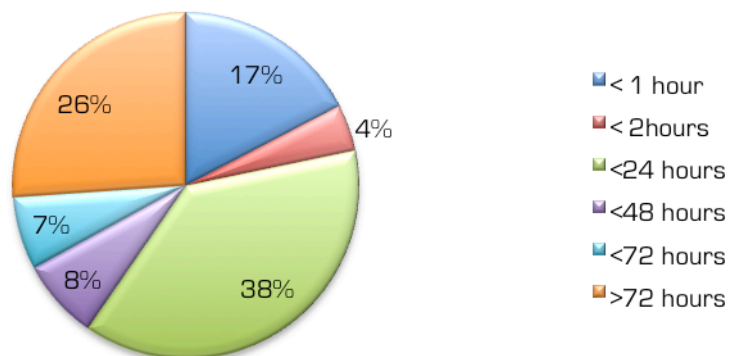
IESG Tickets Resolved by Time
October 2011 - 220 Tickets

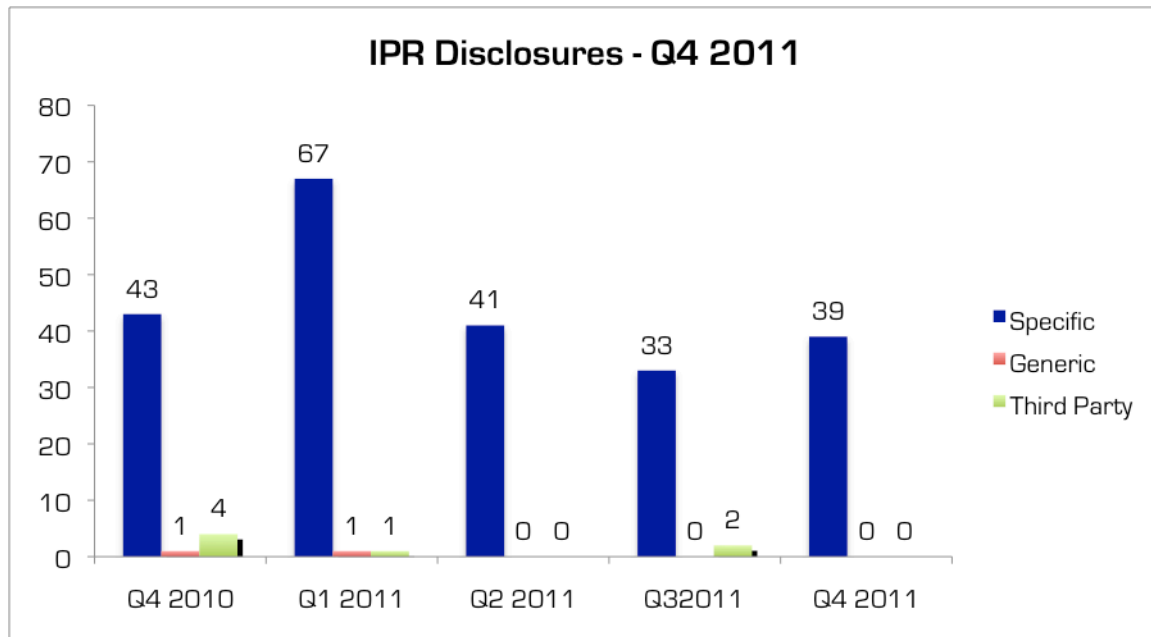


IESG Tickets Resolved by Time

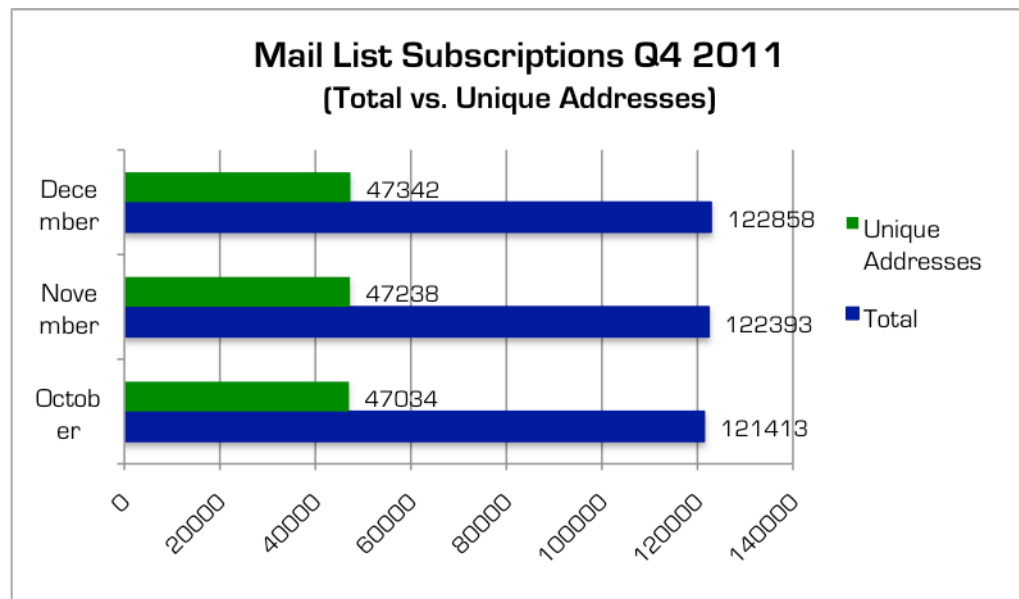

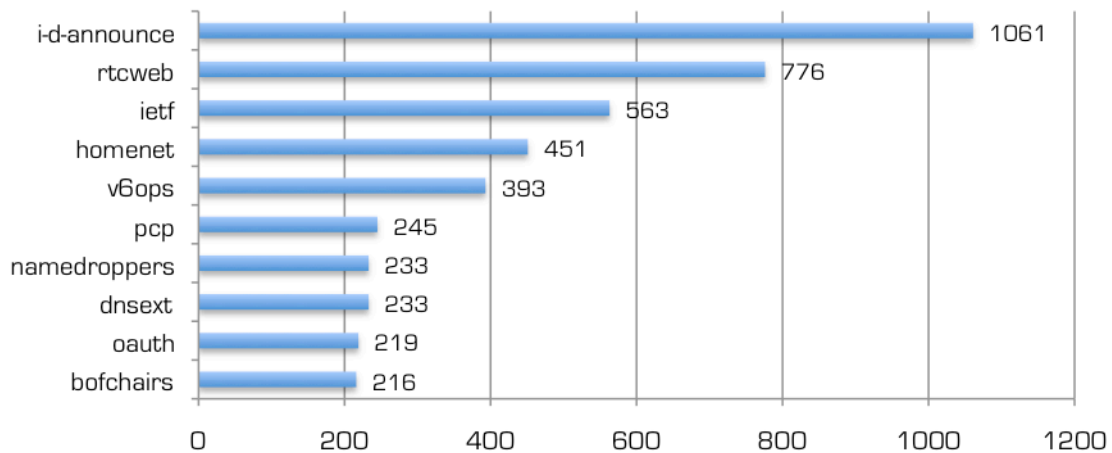

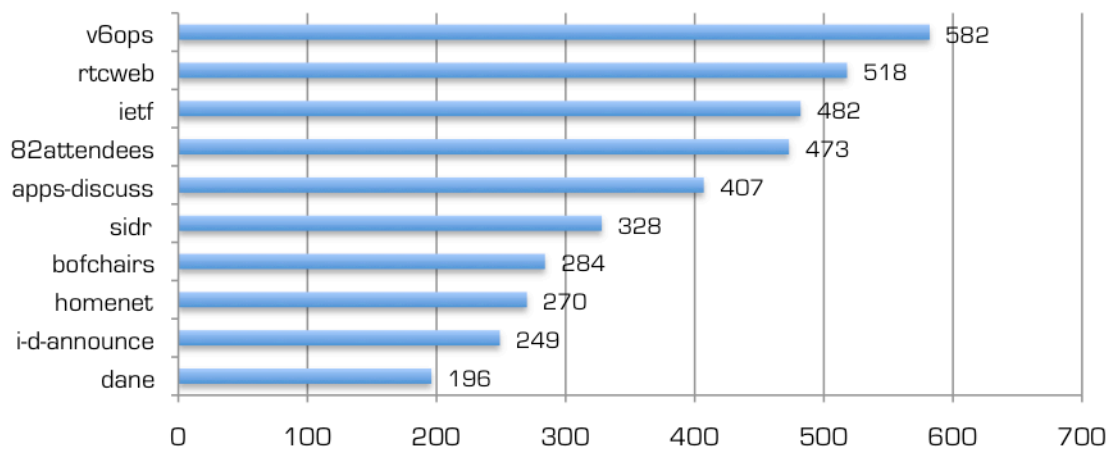
