



Processing IETF Related Requests

A look over the past 12 months (November 2015-October 2016)*

IANA Services Activity

Protocol Parameter requests since IETF-96 (July 2016-October 2016)

Processed more than 1281 IETF-related requests (This includes document reviews, new registrations, modifications to existing registrations and deletions)

More detailed breakdown:

- Reviewed 95 I-Ds in IETF Last Call and 91 in IETF Evaluation
- Reviewed 94 documents becoming RFCs (51 of the 94 documents had IANA actions of some form)

Added 2 new stand-alone registries since IETF-96 (July 2016-October 2016)

SLA Performance

Average cumulative percentage for May 2016 through October 2016 was 99.6%.

The 2017 SLA between ICANN and IAOC for the protocol parameter work is currently being drafted for review and approval.



Update on Projects and Deliverables

Protocol Parameters Review

- Required deliverable in the 2016 SLA
- Third-party review of ICANN's processing of protocol parameter requests
- Third-party auditors have conducted review
- Shortened period due to IANA contract expiration
- Results will be available in December 2016

Annual Customer Service Survey for IANA Services

- Results will be available December 2016
- 94% satisfaction for all IANA Services (names, numbers and protocol parameters)
- Reviewing feedback and identifying improvement areas



Documentation

- Almost there: RFC5226bis <u>https://datatracker.ietf.org/doc/draft-leiba-cotton-iana-5226bis/</u>
 - Working through final edits and additions
 - Improving language
- In progress: RFC6890bis
 - Proposes improved definition for a registry column
 - Corrects an entry in the registry
 - Will be presented at IETF-97 in the intarea meeting
