





## IANA Department Activity

Protocol Parameter requests since IETF-92 (March 2015-June 2015)

Processed more than 1458 IETF-related requests (This includes document reviews, new registrations, modifications to existing registrations and deletions)

More detailed breakdown:

- Reviewed 97 I-Ds in IETF Last Call and 118 in IETF Evaluation
- Reviewed 110 documents becoming RFCs (57 of the 110 documents had IANA actions of some form)

The draft 2015 SLA between ICANN and IAOC for the protocol parameter work is still under review.



## Update on Projects and Deliverables

#### **Protocol Parameters Review**

- Required deliverable in the proposed 2015 SLA
- Third-party review of ICANN's processing of protocol parameter requests
- Currently reviewing controls and third-party auditors will commence reviewing data in Sept/Oct
- Report will be delivered to the IPROC by March 30, 2016

Defining controls for an internal review of the qualitative aspects of protocol parameter processes. Focus is to see if there are any areas of improvement in the quality of the processes and areas for more efficiency.
