#### 2. Action / Discussion items

## a. Recording e-vote of YANGCATALOG resolution

## Background

The IETF is in the process of standardizing hundreds of YANG data models and thousands exist in the industry. YANG is a data modeling language standardized in the IETF that can be used to automate the configuration and management of networks and devices. The use of YANG data models is transforming the way that networks are managed to today.

The YANG Catalog (<a href="http://yangcatalog.org">http://yangcatalog.org</a>), is a tool that has been developed primarily by IETF participants to make it easy for network operators to find and understand what YANG data models exist and how they relate to each other, validate the correctness of models in development and build APIs to manage their networks. The catalog makes searchable thousands of data models from across standards organizations including the IETF, IEEE, Broadband Forum, and others as well as vendor-specific models.

The set of tools that the catalog offers allows operators to integrate the outputs from the IETF

and elsewhere directly into their solutions for automating management of their networks.

To date, the work on the YANG Catalog has been supported by individual companies and has been furthered through collaboration during and in between IETF Hackathons. ISOC has been asked to support this special project as a community resource aimed to help an IETF technology get deployed. It is believed that its further development and maintenance would benefit from neutral support and funding from the Internet Society.

Unfortunately, the request was too late for ISOC's budget cycle; however, ISOC is receptive to the possibility of future funding. In order to keep work in progress, Cisco has agreed to earmark <confidential></confidential> of its Platinum ISOC membership to fund the YANG Catalog for three months under management by IETF's Tools Team. The work has been under development by Pantheon Technologies and will continue under Pantheon.

#### Resolution

Whereas Cisco has earmarked <confidential></confidential> of its ISOC platinum membership to fund YANG Catalog development, the IAOC hereby approves the acceptance of the funds from ISOC for contract disbursement to PANTHEON Technologies and project management by the IETF Tools Team.
