Notes:

- (1) For 2006, the ISOC Board approved a contribution to IASA of \$1,445,918.
- (2) RFC Editor includes actual invoices for Q1 and Q2, plus an accrual for July & August.
- (3) Estimates were used for the August NeuStar invoice, since we have not received an invoice yet.
- (4) IASA tools and special projects represents all costs for RFC copy-edit consultant, who was budgeted by IAD in the "Special Projects" category. On August 15th, the consultant's contract was concluded.
- (5) IAB Support include expenses for 2-day IAB Retreat at the end of May as well as food and beverage charges for the IETF Meetings.
- (6) D&O insurance includes premiums for IETF, IAB, IAD, RFC Editor, IANA Designated Experts and other Working Group Chairs covered under the IETF. It does not include premiums for the IETF Trust.
- (7) The IASA Cost Center does not include any expenses related to the IETF Trust (as mentioned in the * above).
- (8) The IETF Support includes (2) IESG Retreats. The first Retreat was held in San Francisco in February and the second Retreat was held in Boston in May.
- (9) Secretariat and Meetings expense includes credit card fees to process IETF registrations. These fees were accounted for in the IASA Support category through July, but were reclassed to the Secretariat & Meetings category in August which explains the large credit of (\$28,741) in this expense line.
- (10) Through August, the IETF purchased \$12,808 in computer equipment which has been capitalized and is being depreciated over three years. The depreciation expense shows up in the G&A/Governance allocation.
