## 2. Finance

### Sustainability

Jari shared that some things are happening with sustainability, but not nearly enough. There has been some effort to produce an initial draft. Unfortunately, Jari has been too busy to contribute much. This topic will be revisited again after the holidays.

## 3. Meetings

### a. IETF 95 Hotel Situation & Lessons Learned

Ray reported that an announcement notification was sent on 10 December that

Registration would open on 1500 UTC Wednesday 16 December. He noted that in the past we had not announced when registration would open. It was done in order to provide people a more equal opportunity to make hotel reservations.

He said the announcement stated that hotel reservations will include the headquarters hotel and the contracted overflow hotels available at that time.

Further the announcement stated that because hotels in Buenos Aires have a limited number of guest rooms, the IETF has been negotiating contracts with ten hotels. Hotels not available on December 16 will be announced when available.

It was also announced that we will provide additional relevant details such as price, location, cancellation policies and more when registration opens on December 16.

Ray reported that indeed, registration did open on 16 December and provided rooms availability data, for example, Hilton Buenos Aires (Headquarters Hotel, block of 300 rooms), and link to Accommodation Details: <http://www.ietf.org/meeting/95/hotel.htm>

The Registration Announcement stated that the IETF has reserved rooms at the meeting venue and at four other properties all within 2 km / 1.3 miles of the venue; that all hotels offer IETF rates 3 days before and after the meeting, some will for as long as 7 days before and after, subject to availability; that taxis are readily available and inexpensive; and that the IETF network will be available only at the headquarters hotel (Hilton Buenos Aires).

The Registration Announcement further stated: **IMPORTANT:** We are still negotiating with six additional properties and expect to have reservation information available shortly. Please note that if you make a reservation outside of the IETF block at any property, we cannot guarantee that the hotel will honor the IETF-negotiated room rate, cancellation deadline or other details. In particular note the cancellation details on the website for each of the hotels. Each is different and some are better than others.

Scott expressed that we need to be more up front about the information – to ensure complete details are shared. Ray responded in agreement, that we need to make sure that the overflow hotels are ready when we open registration. Further, we need to identify number of tiers and number of rooms per tier, and that we need to communicate that the hotel gave us every room possible.

#### b. IETF 98 Venue Selection

Ray noted that the original IAOC venue selection and contract for IETF 98 in March 2017 at the Fairmont Montreal was canceled by the hotel on 30 October as it would be closed a year for renovation, which included the IETF meeting dates. And, for this reason the IAOC needed to select another venue for IETF 98.

Ray reported that hotel availability for the IETF 98 meeting only 15 months from now showed that more than 25 venues were not available over those dates.

Ray then provided the recommendation of the Meetings Committee for the IETF 98 meeting venue and the venue selection criteria. A recent site visit was conducted on the recommended property; the others have been visited previously.

The offer was on the table for the three meetings, but a contract would have to be executed by the end of the year to obtain the favorable terms for the 3 meetings.

#### 4. Tools

a. 2016 Work

(1) Repair the "broken" messages in the email archive Award

Ray reported out the recommendation of the Technology Management Committee to award a contract to repair so-called broken messages in the email archive.

Ray provided background:

Thousands of 'broken' emails have been discovered in the email archive

- a. Biggest contributor to brokenness in the IETF list is old (circa late 1990s) MMDF handling, resulting in files that don't have correctly indented header continuation, and occasionally spurious blank lines inside the header.
- b. Corruption of the input
- c. Messages that contain Date header
- d. Point errors (in the Date field for example)

The TMC recommends a Task Order with AMS to do the repair work as AMS has worked on the email archive previously and would be able to do the task more efficiently.

The cost to do the work would be a not-to-exceed <confidential> </confidential>.

Ray stated there is money in the 2015 budget to cover the expense

Resolution:

The IAOC awards a contract to AMS to repair the email archive broken emails at a cost not-to-exceed <confidential> </confidential> and requests the Internet Society to effect this award.

Scott moved the resolution and Andrew seconded.
