The RFC Series Editor is seeking information about the availability and licensing of fonts that meet these requirements: (i) Serif and Sans-Serif; (ii) fixed-width; (iii) Unicode support; and (iv) liberal or low-cost licensing terms. Embedded Fonts for the PDF Publication Format for RFCs Request for Information

Description:

The RFC Editor provides editing, publishing and archiving services for the RFC series on behalf of the Internet Engineering Task Force and the broader Internet community. The documents published--Internet standards, best common practices, experimental, and informational RFCs--need to reflect the expectations of a global community of authors, implementors, policy makers, academics, and more (see RFC 6949 http://www.rfc-editor.org/rfc/rfc6949.txt).

As part of the changes required to meet current expectations, the RFC Series Editor announced to the IETF community in 2013 the intent to change the format for RFCs from a single, plain-text, ASCII-only format to a format based on a canonical XML file with multiple publication outputs. One of those outputs will be PDF/A-3 (see draft-hansen-rfc-use-of-pdf http://www.ietf.org/id/draft-hansen-rfc-use-of-pdf-03.txt).

One particular area of concern for the project is around the question of what fonts may be used in the PDF/A-3 format. A requirement for the PDF/A-3 format is that the font information for any and all fonts used for that document be embedded within the file. The purpose here is to make the file as self-contained and stable as possible. Given the combination of needing to embed font information and allowing the use of non-ASCII characters to meet the expectations of our authors, we have a challenge with finding the right fonts for our use.

RFC PDF FONTS REQUEST FOR INFORMATION

Requirements for the fonts themselves include:

- Serif and sans-serif fonts should be available (to meet the requirement in <draft-hansen-rfc-use-of-pdf> for main text and headings).
- A fixed-width font must be available for code, BNF, and any other text that requires such a font as an aid in insuring alignment.
- Wide support for Unicode (which may require multiple fonts) is necessary to support the change that allows non-ASCII characters in RFCs, such as person names in native languages.
- Liberal or low-cost license terms.

This RFI is seeking information on what is available, where gaps exist such that a font might need to be acquired with a for-fee license, and where a font might need to be designed.
