

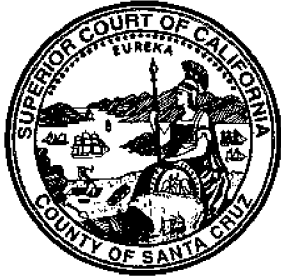
1. Plaintiffs' First Amended Complaint is **stricken**.

The Request to Strike the First Amended Complaint is Granted.

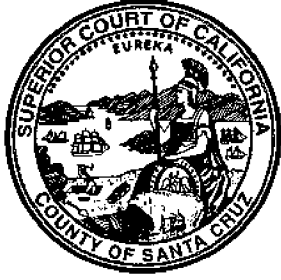
The Motion to Change Venue by Adobe is Granted.


