

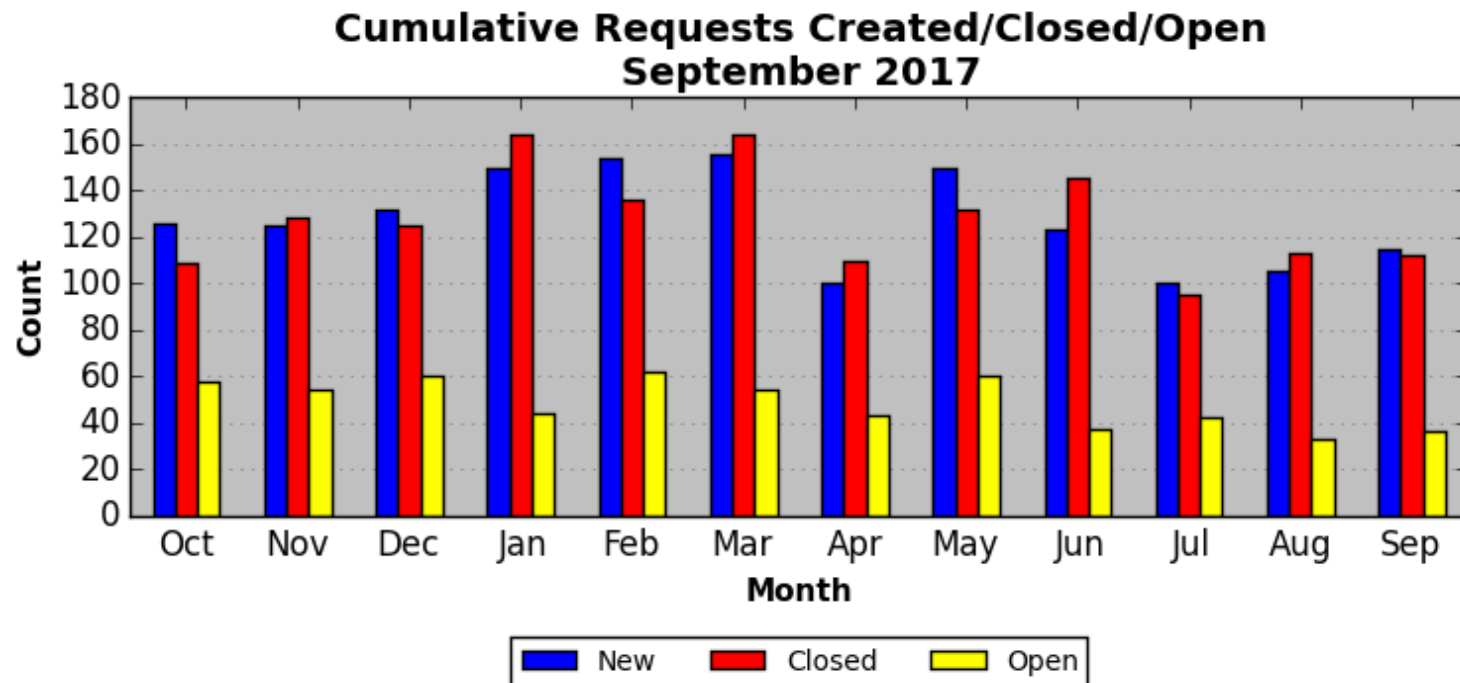

IANA Services Activity

Protocol Parameter requests since IETF-99
(July 2017- September 2017)*

Processed more than 904 IETF-related requests

This includes: Document reviews, registry creations, new registrations, modifications to existing registrations, and deletions.

- Reviewed 62 I-Ds in Last Call
- Reviewed 61 in IETF Evaluation
- Reviewed 50 documents becoming RFCs (30 of the 50 documents had registry actions of some form)
- Media Types 18
- Ports 23

* Only a 3-month period. Normally plenary reports are 4-month periods.
