

IANA Services Activity

Protocol Parameter requests since IETF-101 (March 2018 - May 2018)*

Processed more than 1047 IETF-related requests
This includes: Document reviews, registry creations, new registrations, modifications to existing registrations, and deletions.

- Reviewed 53 I-Ds in Last Call
- Reviewed 81 in IETF Evaluation
- Reviewed 66 documents becoming RFCs (40 of the 66 documents had registry actions of some form)
- Media Types 21
- Ports 28
